COUNSELING

1.1

We do not provide professional counseling or therapeutic services in our programs, though some of our mentors carry professional therapy and/or counseling licenses. Our program is not designed to address mental health, physical health, abuse, emotional problems or sociopsychological trauma, from a medical perspective. Program participants demonstrating a need for professional and/or medical attention in these areas will be encouraged by a member of our team to pursue appropriate services with their parent and/or legal guardian.



In the event of suspicion or disclosure of abuse, neglect, abandonment or death, pertaining to any girl enrolled in our programs, all confidentiality rights and responsibilities are waived and the course of action required by the State of Florida will be implemented.

## MANDATORY REPORTING 2.2

The state of Florida is recognized as a mandatory reporting state, according to the Florida Statutes, Title V, Chapter 39, Section 201. In compliance with the statute we participate in mandatory reporting of child abuse, abandonment, neglect or death (or suspicion of any of the aforementioned.

### **COLLEGE CREDIT**


#### 3.1


## **FOOD PREPARATION** 4.2

Meals and snacks provided through our programs will be obtained from our restaurant partners or purchased from certified grocers and prepared on -site for consumption. A tentative meal menu will be provided for applicable program days so that participants can plan accordingly. Participants who prefer to bring food from home for dietary, health or personal concerns must have a meal waiver form signed by parent or guardian on file.

#### *5.1*.

Our mentor partnerships are not a substitute for parenting, a platform for dating and/or sexual relationships, a platform for monetary gain on the part of the mentor or mentee (i.e. exchange of gifts, whether cash or kind is strictly prohibited). Mentor partnerships are not a substitute for regular attendance in your place of worship, if applicable, or a substitute for counseling and/or prescribed therapies.

#### SENSITIVE MEDIA 6.1

The *Treasured* program combines traditional instructional and mentoring practices with numerous media presentations across diverse platforms including movies, music, poetry, works of art, and performing arts. Some presentations contain sensitive content and/or include discussions and representations that are mature. Parental consent required.

### CURRICULUM

6.2

Portions of the *Treasured* curriculum encourage journaling, self-reflection and personal assessment. These activities may trigger sensitive thoughts, feelings, remembrances of sensitive past or present experiences, etc. Mentors and facilitators are trained to respond with caution, discretion and sensitivity to all such situations.

### **RECORD KEEPING**

7.1

In giving consent for a teen girl to participate in Treasured activities, parent/guardian also consents to attendance recording, participation notes, and mentorship-related assessments made by mentors and program facilitators. Program leaders actively collect and record information to assess and evaluate participant's progress in the Treasured program. Records may be requested by parent/guardian in writing. Records may be used in any capacity deemed fit by Treasured leadership, including but not limited to solicitation of funding, marketing and promotions and all aspects of program development.
